ORDINANCE NO. 168

RULES & REGULATIONS FOR THE WINDFALL CEMETERY, LOCATED IN THE VILLAGE OF GRANTON

The Village Board of the Village of Granton, Clark County, Wisconsin do ordain as follows:

WHEREAS, The Village of Granton has set forth the following rules and regulations for the Windfall Cemetery, located in the Village of Granton

1. NO burial will be made on any lot in the Windfall Cemetery until the Cemetery lot and grave opening has been paid for.
2. All full burials must be made using an approved Cement Vault, from a Vault Company.
3. All grave stones and veterans markers must be set by a Monument Company. A marker must be on the site within one year of the burial.
4. There may be no more than 6 burials of ashes on 1 gravesite, and notification of burial of ashes must be made to the Village of Granton. Only one headstone above ground level in line with the other stones may be place on a gravesite, and any other markers on that gravesite must be at ground level. Burial of ashes over an existing casket burial will be allowed.
5. Policies for a husband and wife burial is for the husband to be buried on the south of the designated lot, and the wife to the north of her husband, unless requested otherwise.
6. Absolutely NO trees, NO shrubs, etc. planted on the gravesite. For trimming of trees or shrubs that were planted before this policy was put into effect... an effort will be made to contact the relatives to trim or have them removed. If no relatives can be contacted then the trimming and/or removal of the trees or shrubs will be left up to the descretion of the Windfall Cemetery Caretakers.
7. Crypts will NOT be allowed in the Windfall Cemetery.
8. Flowers on only for Memorial Day thru June 30th, and if placed on gravestones out of the way of mowing or in permanent urns they will not be removed, however any flowers in the way of mowing will be removed after June 30th.
9. Any person, persons, who violates this ordinance shall be subject to a penalty according to Ordinance #101.
10. Windfall Cemetery nor the Village of Granton is not responsible for any vandalism that occurs at the Windfall Cemetery.

WINDFALL CEMETERY INFORAMTION

The Windfall Cemetery is governed by the Village Board Members of the Village of Granton, with the Village Clerk acting as the Cemetery Secretary. These members have full authority to determine any rules and regulations of the Windfall Cemetery at any and all times.

This platted Cemetery has been platted by a land surveyor and registered in the State of Wisconsin, as the Windfall Cemetery. There is no other platted cemetery in the Village limits of Granton, Wisconsin.

All burials of human remains within the boundaries of the Village of Granton, Clark County, Wisconsin shall be in the platted cemetery, known as the Windfall Cemetery.

The lot that is purchased is for the purpose of the burial of human remains only and for no other purpose whatever. The title to that lot only grants the owner that right to the burial of the purchaser and members of the purchaser's family.

The Windfall Cemetery Board Members must be notified at any time a transfer from a lot is being considered, as approval must be done along with proper paper procedures that must be done so proper records are on file of the transfer.

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND POSTING IN THE VILLAGE OF GRANTON ON DECEMBER 8, 2010.
