Dear project stakeholder,

The Village of Granton, in conjunction with the Wisconsin Department of Transportation, is proposing to construct new sidewalk along South Main Street/County K between the Granton Convenience Store and East 5th Street. The project is located in Sections 1, 2, 11, and 12, T-24-N, R-1-W, Village of Granton, Clark County, Wisconsin as shown on the enclosed project location map.

On behalf of the Village of Granton, we would like to invite you to a Public Involvement Meeting for the South Main Street/County K Sidewalk project.

The Public Involvement Meeting will be held on Wednesday, January 14, 2026, from 5:00 PM – 6:00 PM at the Village of Granton Fire Station, 21 S Main Street, Granton, WI 54436.

The meeting will be conducted in an informal open-house format, with a brief presentation starting at 5:00 PM. Stop by anytime during the meeting to see exhibits and ask questions. Project information will also be posted on the Village of Granton's website by the meeting date and clicking on the "Main Street Sidewalk Project Information" link. The Village of Granton Fire Station is ADA accessible. Persons with hearing impairments who wish for special interpreter accommodations should contact WisDOT at least three working days prior to the meeting through the Wisconsin Telecommunication Relay System by calling 711 or (800) 947-3529.

The purpose of the project is to provide a route for pedestrians between businesses on the south side of the Village of Granton, connecting to sidewalk constructed during the 2024 Main Street reconstruction project.

The proposed project, which is currently being designed by Jewell Associates Engineers, Inc., will consist of new concrete sidewalk along South Main Street/County K beginning at the Granton Convenience Store and connecting to the existing sidewalk at East 5th Street and along Granton

Road from the proposed sidewalk on County K to the Dollar General. The sidewalk is proposed along the west side of County K from the Granton Convenience Store to Romadka Avenue, and along the north and northeast side of South Main Street/County K between Romadka Avenue and East 5th Street. The proposed sidewalk will be 5-feet wide and include the construction of curb ramps meeting ADA design standards. County K and Granton Road will remain open during construction of the sidewalk, but there will be shoulder and lane closures at times to accommodate construction operations. Short term, temporary driveway closures will be required to construct the sidewalk and match driveways; property owners will be notified during construction when their property access will be impacted. Right of way acquisition will be needed for this project. Construction is currently scheduled for 2027.

A separate reconstruction project is proposed to improve the County K/Granton Road/Romadka Avenue intersection to a 4-way stop to improve vehicle movements, safety, and pedestrian crossing locations. Construction is currently scheduled for 2026, pending funding.

Persons with concern for or knowledge about historic buildings and structures and archaeological sites are encouraged to attend this meeting or provide comment to the local units of government or the consultant.

A comment form is included with this letter. Persons with comments or concerns regarding the project are encouraged to provide comments to Jewell Associates Engineers, Inc. by returning the comment form no later than February 13, 2026.

We look forward to meeting with you. If you have questions you would like to discuss, please plan to attend the Public Involvement Meeting.
